FRONTIER JULY COUNCIL MEETING

1. Motion to approve June minutes – Wade Borth Second – Gayle Anderson In favor – Borth, Anderson, Metcalf
2. JH Sign – Perry will call them tomorrow, no check from them yet.
3. No more payments from 2 late sewer yet.
4. Fireworks – no complaints, went well. Discussion held.
5. Jessica talked to resident about ‘no sump pump’ hose – it was connected to their drain field. Just a reminder – all sump pumps should be discharged to the ditch, not into city sewer system.
6. Visto has moved equipment from roadway, west of city building, after letter from council. Discussion held.
7. Drainage: from city building to frontage road and 32nd St./frontage road ditch: one bid received, try to get one more bid by next meeting. Discussion held, time to get this done right. ***** Also: price for culverts that need new end caps – (includes apron for each side and installation: 15” \$410.36, 18” \$452.33, 21” \$514.43. Individuals who are interested in having that done to driveway culverts, at their expense, should contact BJ about this.**
8. Recycling: Waste Management is offering this to Frontier. 96 gallon tote for each household, there is no sorting of materials and anything on the acceptable list can be thrown together into the tote. (wm.com) \$5.50 –per month per household for the first year. Would require all homes in the city to be billed for recycling services. **** Please contact a council person and let them know your views on this.**
9. No bill received from Airborne Spraying yet, two applications have been done.
10. Building permit issued for Molm.
11. Questions about removal of dike on east side: concern about drainage from back years: they cannot ‘flood’ our back yards. Invite Jason (City of Fargo) to next meeting, to answer questions about his.
12. Telephone lines – who owns them? A lot of them are tipped over, rusted, etc. Neil will contact Century Link.
13. Question about loan payments: monthly, covers interest. Have made payment to draw down balance of loan.
14. Discussion about seal coating – needs to be done
15. Remember to include financial statement with monthly minutes.
