FRONTIER AUGUST COUNCIL MEETING

Present: Neil Krueger, Gayle Anderson, BJ Blanchette, Wade Borth, Jonathan Garaas, Joann Brandenburg

1. Motion to approve July minutes – Gayle Anderson Second – Wade Borth
In favor – Anderson, Borth, Blanchette
2. No late sewer payments in – Neil talked to one of them, will try to contact the other.
3. Business to west had moved things, brought back, and now moved out again. Drainage to west of city bldg., along closed street: \$13585 – grade ditches, drain to the west, cut ditches, etc. Bid for work at north end of 32nd, frontage - \$14,000 would be adding 4-6 inch rock to prevent washouts. Discussions held.
Motion to approve bid of \$13585 – sw corner of city – BJ Blanchette Second – Gayle Anderson In favor – Blanchette, Anderson, Borth
Motion to approve pricing, as per last meeting, for repairing of city culverts, up to 10 culverts – Wade Borth Second – BJ Blanchette In favor - Borth, Blanchette, Anderson
4. Recycling – 5 responses were received by council: 2 no, 2 maybe and 1 yes. Will not do anything about this at this time, maybe discuss at a later date, if more interest is shown.
5. Questions about removal of dike, behind homes east side of city: contractor for Fargo will not touch backyards in Frontier. Jason (Fargo) and Neil will try to get together and look at this. Question raised: do we have anything in writing that they cannot cause flooding because of the new lots being added behind Frontier?
6. Neil tried to contact Century Link, could not get thru to them, about telephone towers in yards many of which are fallen over, etc. Wade will try to contact them this month.
7. Seal Coating – needs to be done in spring. Question as to when paving was done, when will specials be done on this?
8. Rec'd bill for mowing – 3 times – Valley Green
9. Appoint a Vice Mayor – BJ volunteered.
10. Complaints about barking dogs on 34th St. – Neil will contact resident, not first time complaints have been made about this.
11. Complaints about 4 wheelers – need to follow speed limits, be respectful of other people's property, etc.
12. Tammy Owens – had talked to state senator – need to plan ahead 2-3 years to get any state funding for streets etc. Need to get planning together for next session.
13. ***Please pick up pet waste when you are walking them around the city – This means along the streets and ditches!! Other residents do not appreciate your pets' waste!!
14. 2016 Budget – want a more accurate budget, need total for year income for next month, copy of previous budget to Wade. Need to have 2016 budget to Cass County by October 10.
