1. Motion to approve August minutes – BJ Blanchette Second – Gayle Anderson In Favor – Blanchette, Anderson, Borth
2. Late sewer – money rec'd from one resident.
3. Ditch work – ditch has been done west of city building, 11 culverts were repaired, couple more could have been done.
4. Jason (city of Fargo)- Neil talked to him, said that they cannot cause flooding in backyards of Frontier, but cannot do anything in writing. If there are any issues, they will be addressed.
5. Century Link – Wade spoke to a technician, about towers around town that are fallen over, etc. Supposedly will be fixed.
6. Discussion on seal coating, will be looked at next spring.
7. Complaint about roughness along 52<sup>nd</sup> ditch – look at smoothing out, reseed next spring. Also check into mowing.
8. Barking dogs (34<sup>th</sup> St.) Neil spoke to resident, didn't get anywhere. Suggestion to call sheriff when there is a problem, maybe noise ordinance?
9. Complaint about 4 wheelers, side by sides, etc. exceeding the speed limit in Frontier. Residents need to obey traffic laws within the city, and show respect to other residents.
10. Wade has looked into money available from the state for seal coating, etc, should be receiving appropriations from Cass county. Discussion held.
11. Scott Trenda – looking at purchasing house on 35<sup>th</sup> St., but wants to get approval for extra garage first. Will have to make adjustments, needs to be 75' from property line, not 75' from center of road. Needs to talk to Perry about this.
12. Community Center has been rented for a few occasions, need to promote this more. Still a lot of things to be done in the yard: pour concrete sidewalk, etc. , level and seed yard.

13. Garage in back yard at Christianson's – was supposed to be removed when addition was finished – BJ will talk to them about that.
14. Discussion held about 2016 city budget. Motion to approve 2016 budget as presented – BJ Blanchette Second – Wade Borth In favor – Blanchette, Borth, Anderson
15. Chris Hesse had talked to Neil about renting building and lot for get-together with RV friends, etc – will talk about this next month.
