1. Motion to approve August 2016 minutes – Jon Whiting Second – Adam Silbernagel

2. Neil Krueger, representing his mother-in-law LaVerne Nelson-Bengtson, presented the city with a check for \$1000 to be used for flag pole, etc. Laverne was one of the original residents of Frontier – see attached letter. Thanks to Laverne for her generous donation.

3. Special election for mayor – December 6. Petitions for nomination may be picked up at city auditor, must be returned by 4 p.m. October 3. This is to get your name on the official ballot. A legal notice was printed in the Forum, also notice was hand delivered to all residences. Will need 3 workers for the day of the election, will discuss next month.

4. Landscaping/city lot – BJ is following up on that, should be finished soon.

5. Resident's complain about dirt placed in ditch on 33rd – Jon checked this when we had the big rain, does not seem to be a problem. Home owner is aware that he is responsible if this becomes a problem.

6. Ditch to west of community center – mesh was laid, grass is growing.

7. Electrical outlets for outside of center – Motion to hire Advanced Electrical/Mike Himmerick to install, not to exceed \$1000 – Jon Whiting Second – Adam Silbernagel
In favor – Whiting, Silbernagel, Borth, Metcalf. Also, Wade will bring a flag.

8. New owner of home on 32nd St. had questions about putting up a fence, what are the setbacks – nothing in the ordinances, Fargo and West Fargo are 12 inches from lot line, so go with that.

9. Budget 2017 – discussion, same as last year. Motion to accept the 2017 budget as written – Jessica Metcalf second – Jon Whiting In favor – Metcalf, Whiting, Borth, Silbernagel.

10. Question about the sewer agreement that was signed with the City of Fargo, need copy of this, something that could be posted on the website.
