auditor. Proof of residence required if your name is not on the list. Auditor and workers  
will count votes immediately following close of voting time. Canvassing board will review  
votes at beginning of the Dec. council meeting. Drawing was held for placement of  
names on ballot – 1<sup>st</sup> –Terry Chambers 2<sup>nd</sup>- BJ Blanchette. Absentee ballots will be  
available from auditor (please call or email, to pick one up). Joann will prepare a ballot  
box, to be inspected by workers before voting starts.
3. Flag will be put up on Sunday, by Cub Scouts, under Wade Borth's direction.
4. Same snow removal as last year.
5. Question as to when septic systems will be pumped – on a schedule for every three  
years, so should be happening next summer. This is set up by the City of Fargo.
6. Complaints have been brought to the council's attention about burning of leaves/grass.  
Smoke has become a problem. Discussion held. Hard to have an ordinance banning  
burning, who would do the enforcement on this? Talk to your neighbors; be aware of  
conditions if you are planning on burning. Will discuss this again in the spring, monitor  
it.
