1. Motion to approve July minutes – Jon Whiting Second – Wade Borth In favor – Whiting, Borth, Silbernagel
2. Cracks have been sealed.
3. Dirt Dynamics have not started the pumping of septic tanks, will be starting soon.
4. Jon sprayed the community center yard.
5. Second reading for amended 2017-1, section f. #1 is amended from 800 sq ft to 1000 sq ft., and exterior to have similar materials as main buildings on lot. – motion to accept – Adam Silbernagel Second – Jon Whiting In favor – Silbernagel, Whiting, Borth.
6. Center rentals – fillable form and calendar on website. Need filled out form and payment to reserve a date.
7. Budget will be addressed at September meeting.
8. iLevelDigital/ Paul: would like to put up sign on northeast corner of Frontier. City would receive 5% of the monthly gross, also do work in the ditch along the frontage road there. Discussion held: how does city control this, who approves content of advertising, etc. Will discuss next month. Need info from Garaas.
9. Dawn Kuntz – they have a sewer issue, discussion held. Jon will call city of Fargo with questions about this, also need more info from Kuntz about who they talked to, etc from Fargo.
10. Ditches-culverts: email from Finley about erosion on frontage (34th St.) can't mow there; Boese had complaint about culvert and dirt next to residence. Council will talk to Garaas about these issues.
11. Molm was concerned about fire in Round Hill, we do not have fire hydrants within our city. Problems will insurance rates. Perry will speak to Hagel (Horace fire dept) about this, BJ will call Cass Rural Water about hydrants.
12. Where can tree trimmings be taken – take to Fargo landfill. Discussion about having a container at the city lot.
