FRONTIER OCTOBER 2017 COUNCIL MEETING

1. Motion to approve September 2017 minutes – Wade Borth Second – Jessica Metcalf, in favor – Borth, Metcalf, Whiting, Silbernagel
2. . ILevel digital / Darren Voeller: presented a proposed ordinance, for allowing signage in northeast corner of Frontier. Discussion held. ILevel’s attorney, Steve Welle, provided an opinion as to whether the sign could be placed in northeast corner. Garaas stated that the city could not accept money from the advertising sales. More discussion, Voeller will check with Fargo about drainage, contract. More next month. Jon – what is consensus on sign? If we can’t accept money, why do it?
3. Jim/ City of Fargo - sewer issues. Discussed possible increase to sewer fees which would go to a ‘capital repair fund’. Will look at this amendment next month. Discussion about a resident’s septic tank failure/collapse. What can be done? Kuntz wants a letter from city stating they need a septic tank.
4. Brian Oak – planned to put steel siding on new garage, steel roof. City states it has to be same materials as home. Ordinance states same materials, permit does not read that way. Planning and Zoning needs to meet, and discuss this issue.
5. Dirt Dynamics/septic pumping is still working out here.
6. Snow Removal – Jamie (who has done removal the past few years) stated he could do it again. Motion to have him do snow removal for this season – Wade Borth Second – Adam Silbernagel In favor – Borth, Silbernagel, Metcalf, Whiting
7. Ditch north of Finley’s – Wade sent email to Accelerated Greenworks, if they could mow this.
