1. Motion to approve January 2018 minutes – Wade Borth Second – Jon Whiting

2. Election – June 12. Petitions for nomination can be picked up from city auditor. 5 signatures are needed on council petitions, 3 signatures on mayor petition. **Petitions must be turned in to Frontier City Auditor by April 9, 4 p.m.** Positions up for election: Mayor (BJ Blanchette) , two council (Wade Borth, Jessica Metcalf) No petitions have been picked up or returned yet. Please consider serving your city in one of these positions.
3. Rewrite building permit – group met tonight. This will be added to #1 –
Exterior Building Material: The same or similar quality and scale exterior building materials shall be used in the accessory buildings as in the principal building. All accessory buildings shall also be compatible with the principal building on the lot. “Compatible” means that the exterior appearance of the accessory building is not at variance with the principal building from an aesthetic and architectural standpoint as to cause; a difference to a degree to cause incongruity or a nuisance.
First reading was held tonight.
4. Discussion about playground equipment, maybe getting grant money, etc. Also, check on cost of insurance for this.
5. Discussion on snow removal.
6. Fargo has raised the cost of monthly sewer fees, Jon will talk to City of Fargo about this.
7. Replacement of flag – donation from Penfield’s.
8. Rental of center – some confusion about renting. Payment must accompany application before it will be reserved. More discussion held.
9. Bill received from Advanced Electric for replacement of photocell – outside light.
10. Wade presented the question of home rule charter, discussion held.
11. Perry Ronning – several calls about remodels, not much else.
