2. Discussion about ditch along 56th Ave, Arvig – Terry tried to contact them, did not return calls, etc. Have attorney draft a letter to them concerning ditch drainage, if there is spring flooding problems, costs will be charged to them.
3. Clean leaves from culverts by your properties.
4. Still speeding problems, Cass County Sheriff dept. has been thru a few times.
5. Pumps – Jon will check these.
6. Extension of note on community center – signed. Try to have Burchill from Bell Bank at next meeting, to explain different options – continue same, loan, etc.

8. We have a new contact with the Cass County Sheriff Dept. – Deputy Ray Mosley
9. Jim Stewart contacted city to issue its revenue bonds to Red River Human Services. Documents will be provided by next meeting. There is no cost/risk to Frontier, and will be paid for use of these.
10. Home Rule charter – previous motion had expired – Motion to cause a home rule charter to be framed and submitted for adoption to the qualifies electors of the City of Frontier in the manner proved by ND Century code 40-05-1. – Jon Whiting 2nd – Terry Chambers In favor – Whiting, Chambers, Borth, Silbernagel. Need to appoint a “charter commission” of at least 5 members. Volunteers so far – Tami Owens, Tom Molm, Jon Whiting, Adam Silbernagel. Need at least 1 or more volunteers. **Everyone should have Frontier as their city address/shipping address.
