Motion to approve the 2021 values set by Cass County – Adam Silbernagel 2nd – Terry Chambers In favor – Silbernagel, Chambers, Whiting, Borth

2. Cass County sheriff report- one theft of catalytic converter, nothing else.
3. Fireworks permits – presently at \$5000, talked about raising by amount of assessment raise of properties. Motion to raise amount by 3% (\$150) starting with 2021 permits – Wade Borth Second – Terry Chambers In favor – Borth, Chambers, Whiting, Silbernagel.
4. Tri State Paving bid - \$5360 Motion to accept bid – Adam Silbernagel 2nd – Terry Chambers In favor – Silbernagel, Chambers, Borth, Whiting. Wade will check on certain cracks.
5. Center floor needs cleaning – Motion to do floors, not to exceed \$500, Terry Chambers 2nd – Wade Borth In favor – Chambers, Borth, Whiting, Silbernagel. Terry will check into this.
6. Keep ditch mowed along frontage curve – FM Landscaping will do twice a summer. Discussion about water sitting in certain ditches, etc.
