5. Election – June: received 3 petitions for council, 1 for mayor. Drawing done for placement on ballot: council -

6. Grace Olson – more research on planting trees. City will be planting 7 trees in city land 32nd and 56th, along with the Olson's planting trees on their land. City cost \$1800 for trees and planting. Motion to accept – Terry Chambers Second – Wade Borth In favor – Chambers, Borth, Whiting
7. Living Local app – not enough info, not for now.
8. Fireworks permits – were \$5250 last year, will raise to \$5500 for 2022. Also let them know about home rule charter, sales tax.
9. STOP signs mean stop – residents are running signs. Complaints have been rec'd, Sheriffs dept. have been let know. Also, discussion about no stop sign at end of 34th Street, only on frontage road. This was set by the state, can ask questions to them.
