- 9. Fireworks permits now \$4000, discussion held as to raising fee. Motion to raise permit fee to \$5000 annual fee for 2013 Jerry Meier Second Gayle Anderson In favor Meier, Anderson, Blanchette, Olsen. This is considered the 1<sup>st</sup> reading of ordinance to raise fireworks permit.

- 11. Appliances have been purchased Greg checked prices at 4 different places, Home Depot had best prices, purchased there.
- 12. Discussion held as to applying for off peak from Cass Electric. Decision made to not go with off peak.
- 13. Discussion about functions of the community center. Should there be a fee or deposit for use? Need to write up an agreement for users to sign, only residents can use it. Have a signup sheet and someone to be in charge of this. Someone will need to inspect building after every event.
