- 1. Motion to approve March meeting minutes Jerry Meier Second BJ Blanchette In Favor Meier, Blanchette, Olsen, Anderson
- 2. City Building Smithco bill was paid. First electric bill was about right heat is now turned down to 50 when nothing is being held there. Will leave off peak at propane, as gas lines are not close to lot. Felt pads needed for table and chair legs. Blinds have been installed by BJ. He is still checking on telephone/cable/internet package. Also checking on garbage service don't need pickup every week, will see what is available. Misc. items for the building are being picked up by Gayle and BJ. Greg had keys/locks done for file cabinets, etc.

Backhoe was called in for second day, to clean a main drain on 56th that was not done on first day. - 8. Pumps and generators were checked a year ago, are in city shed. Maybe think about moving that shed to lot next fall, will discuss later.
- 9. Motion to purchase the kitchen cabinets, countertop, etc. from Home Depot(discount this week) Gayle Anderson In favor Jerry Meier In favor Anderson, Meier, Olsen Abstain Blanchette. BJ will have them delivered; BJ, Neil and Jonathan are meeting on Saturday morning to install.

- 11. Cracks in streets Jerry will contact firm immediately to be put a list. Cracks were very deep last fall, may need filler first. Discussion held.

- 3. Discussion about installing a ceiling fan, maybe directional for the vents. Also need a couple of fire extinguisher, fire alarms, etc.
- 4. Nothing was reported for planning committee.
