

## FRONTIER COUNCIL MEETING

- 1. Motion to approve March 2014 minutes Gayle Anderson Second BJ Blanchette In favor Anderson, Blanchette, Olsen
- 2. Tax Equalization Meeting/ Bob Staloch, assessor: County is mandating a 5% across the board raise in assessed values. Houses sold for about 20% above assessed values this past year in Frontier. Discussion held. Motion to accept assessment changes as directed by Mr. Staloch Gayle Anderson Second Wade Olsen In favor Anderson, Olsen, Blanchette.
- 3. Oye property- waiting for judge to schedule a court date.
- 4. Business property SW side of city trailers, etc. have been moved.
- 5. Jerry will contact Asplin, not able to meet on April 15. Discuss clean up of ditch south of city lot, also ditch north of Brandenburg's, needs shaping, black dirt, and was also dug up when snow was cleaned out of ditches.
- 6. Election candidates for offices: Neil Krueger is running for mayor. Two council positions open, Wade Borth and Jessica Metcalf turned in petitions for council. Election will be held June 10.
- 7. Neil was contacted by a resident of Fargo, living south of Frontier, about raising the speed limit on the frontage road. Discussion held, driving above speed limit now, not stopping at stop sign by 34 St. Leave speed limit as is for now. Other speeding issues problem on 33<sup>rd</sup> with red car excessively speeding. Discussion held.
- 8. Lock box is installed in back room, for extra keys for building, shed, etc.
- 9. Sewers will probably be pumped this summer, City of Fargo will notify when this will be happening. Mark your sewer pipe, to make it easy for workers.
- 10. Plans for east side of Frontier: Terry Petrich attended the Fargo meeting. Got a map detailing plans. He had voiced the concerns about drainage out of Frontier, along 56<sup>th</sup> Ave. thru the field, and also backyard drainage. City will send a letter/email stating our concerns.
- 11. Mosquito Control aerial spraying: Signed contract, Gayle will again be contact. Airborne requested to increase our spray area to 276 from 175. Gayle will talk to them about this, before Joann sends in paperwork. Council does not approve increase.
