1. Motion to approve July 2014 minutes – Gayle Anderson Second – Wade Borth In favor – Anderson, Borth, Metcalf
2. Court date set for Oye property – September 16. Discussion held.
3. Pump o storm sewer west of city building – no bids in yet. Tress have been removed from ditch area, a lot has been cleaned up. Road could be opened up now. Paving repair bids – contacted 5 different places, no responses, would like a more competitive bid than Tri State. Cutting Edge Groundscare have done some work, is working on it. Their bill will be readjusted, because of work done by church. Motion to pay bill for lawn mowing – Gayle Anderson Second – Jessica Metcalf In favor – Anderson, Metcalf, Borth.
4. Discussion held on work to east of Frontier. The culvert on the east end of 56th must be removed, bid from Fargo was for \$6500. Rec'd a bid from Cutting Edge for \$2500. Motion to accept bid from Cutting Edge Groundscare for \$2500 – Gayle Anderson Second – Wade Borth In favor – Anderson, Borth, Metcalf. Work to be done this fall.
5. A lot of culverts thru out the city need work, Neil replaced ends on one, in about 2 hours. Maybe check with Cutting Edge if they would be interested in bidding?

6. Community party – discuss next month.
7. Fireworks problem – rec'd complaint from Tamara Owens/33rd St. about fireworks a full week ahead of the holiday, late nights. Discussion held, maybe set some limits as to when they can be used, such as West Fargo did this year.
***Council would like input from residents, thoughts for or against fireworks, setting limits etc.
8. Germanson addition – rafters are being delivered Sept. 9, work will start this week.
9. Renting of community center – Chris Hesse will be in charge of this. Discussion held about non-residents wanting to rent this. Would like to have more residents using this facility.
10. Water pressure/Cass Rural water. Wade spoke to Cass Rural Water, they contact Neil Krueger and replaced valve, some may be original to houses in city. ** If you are having problems, contact Cass Rural Water and they will check this out for you.

2. Septic Tank pumping has been done, and finished within city.
3. Ceiling fan will be installed tomorrow in building, by Advanced Electric
