1. Motion to approve August 2014 minutes – Gayle Anderson Second – BJ Blanchette
In favor-Anderson, Blanchette, Borth, Metcalf
2. Discussion about cleaning storm sewer southwest side, calls made but not any responses. MVM may bid it yet, hopefully by next meeting. Discussion about opening up cul-de-sac -35th and road west from city building, maybe keep closed but not use as a parking lot for business. **** Council would appreciate residents' ideas on this matter****
Motion to pay bill from Cutting Edge Grounds care for cleanup of ditches by city building, and two mowings – BJ Blanchette Second – Wade Borth In favor – Blanchette, Borth, Anderson, Metcalf. Fixing of bad street areas will have to wait until spring, also look at seal coating at that time.
3. Removal of culvert at 56th – has been too wet. Discussion about work east of Frontier.
4. Culverts need work, city and residential, but not many companies want to do this. Markers need to be put on culverts again for spring cleanup.
5. Community party – very busy time right now, will set something up for January or February, Wade appointed to be in charge.
6. Fireworks problems – discussion held. Years ago was set up for 3 days before, 3 days after the 4th, don't know about time limits. Will try to find this in past minutes.
7. Request made for a nonprofit group to hold monthly meeting in community center. Leader is a resident of Frontier. Gave info to Chris Hesse. Discussion held.
8. Sewers have been pumped, if any problems please contact Pete Bilstad-City of Fargo Sanitation. Also, complaint about ditch on 34th St., construction work was done but ditch as never cleaned up/put back to original. Neil will check.
9. Fan has been installed.
10. Update directory
11. Article about Prairie Rose in the Forum, Neil did return call from the Forum, but they never called back.
12. Neil spoke to Horace Fire Chief about their ratings (for insurance purposes). They have very good rating, under 10 minute response time. Frontier's biggest problem is no fire hydrants in the city. More next month
13. Financial report was included in last month's minutes, will continue.

14. Snow removal – current contractor said rates same as last year. Neil also rec'd a couple of letters from interested contractors. Will compare next month,
15. Some residents have been contacting Xcel Energy about installation of gas to their properties. Very high prices were quoted; Neil will make some calls on this.
16. Discussion about 4 way stop – helps exit out of Frontier. Temporary light will be installed. Neil has talked to Fargo about speeding down frontage road, and no u turn problems
17. Budget 2015 – up snow removal to \$6000: suggestion to put frontage road charge into some type of maintenance fund – discussion on different funds, not just general fund. Do 3 year average; maybe put into current savings account?
18. Continuance of Oye court date, until October or November, doctor's letter stating it could negatively affect mental health of Mrs. Oye. Discussion.
