1. Motion to approve minutes of June 2022 meeting – Terry Chambers Second – Adam Silbernagel In favor – Chambers, Silbernagel, Terry
2. Repairing of lawn – Terry Will meet with Terry Murphy, get an estimate of cost to repair.
3. Discussion on stop signs, going out of 34th street, and coming in on 34th street. Jon will talk to DOT about this, leave as is for now.
